5. General Secretary's Report

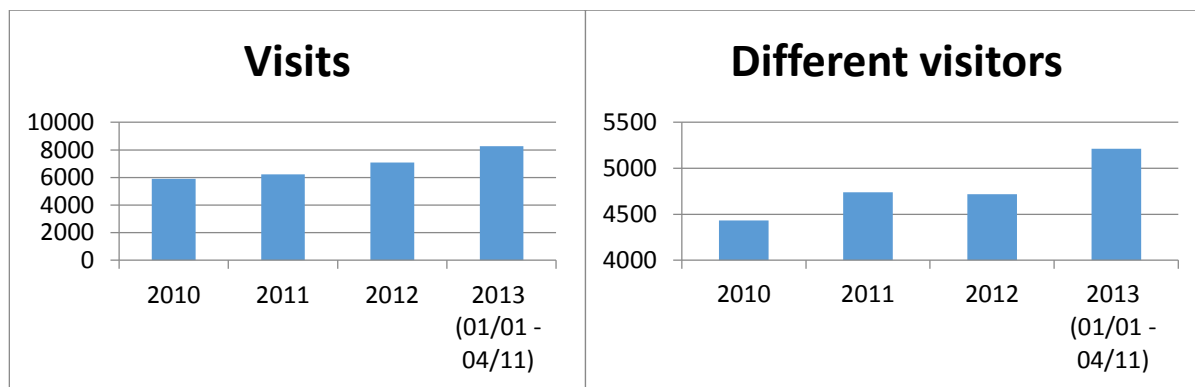
Daphné Bolz, Secretary General, mentioned CESH members. We have 12 members less due to the lack of congress.

6. Treasurer's Report

7. Auditors' Report (Jallat & Faniopoulos)

8. Vote on the four reports

9. Nomination of two auditors

10. Election/Continuation of the General Secretary (González Aja/Loudcher)

Daphné Bolz is proposed to continue being the Secretary General.

Votes: All in favour.

11. Presentation of the new President of the College of Fellows (Gonzales Aja)

Teresa González Aja thanks the valuable help of Joachim Rühl. She continued Riordan's work, a very difficult task. Angela Teja is proposed as the new president of Fellows.

Votes: All in favour but 1 abstention.

Angela Teja thanks Teresa González Aja. She has a hard task after so good presidents of Fellows before her. Maria Mercedes Palandri will be Angela Teja's Secretary.

12. Presentation of a new fellow of CESH (Gonzales Aja)

A new Fellow is proposed: Marcello Marchioni.

Votes: All in favour.

13. Reports on proceedings

a) Pisa Proceedings (Teja/Marchioni)

Angela Teja. She wants to make a selection of texts. Krüger and Marchioni will help her although she does not know about dates.

b) Monastir Proceedings (Elloumi/Viuda Serrano)

Alejandro Viuda-Serrano. Everything is ready to publish proceedings. Thanks to Loudcher and Elloumi.

c) Estoril Proceedings (Hasse)

Manuela Hasse. No news.

d) Barcelona Proceedings (Pujadas/Viuda Serrano)

Alejandro Viuda-Serrano. He will send guidelines for authors before summer with the intention to get proceedings published by the end of 2014.

14. Presentation of the 18th Int. CESH Congress 2014 in Edessa (Faniopoulos)

Christodoulos Faniopoulos presents the next CESH congress in Edessa (Greece): photos of the place, the city, facilities... Edessa, a foot-friendly city. Venue for the congress. Visits, cultural activities (waterfalls, Alexander the Great, etc.).

Presentation of the website of the congress. General topic: "Education and sport". Open session for papers of other topics.

Dates: 16-18 October 2014.

Fees: Very affordable prices, not exceeding EUR 100.

It is necessary to be a CESH member to participate in the Edessa congress.

Aegean Airlines: Very good prices for the congress participants.

Thessalonica Airport the nearest one. 75 minutes by train or bus to Edessa. From Macedonian airport 90 minutes.

15. Proposal for the 19th Int. CESH Congress in 2015.

For the XIXth CESH Congress Denis Jallat proposes to host the congress in Strasbourg (France) and Marcello Marchioni proposes to host the congress in Florence (Italy). The candidates and the assembly propose to let both candidates agree between them on which year they want to organise a CESH congress and to get back to the Directing Council of CESH with their decision.

CESH Vice-president will be the one who organises next Congress. Votes: All in favour but 2 against.

Votes on all the rest of changes: All in favour.

Mike Huggins asked Daphné Bolz to circulate the new statues.

INTERIOR REGULATIONS. Changes voted: All in favour but 1 abstention.

Statutes

Preamble

In order to maintain and promote a positive sports culture in Europe, a complete awareness of the common heritage of physical education and European sports is needed. A specific future cannot be created without appropriate knowledge of the past.

Responsible development of the common cause in promoting European Sports History demands the following:

- favouring cooperation among sports historians in Europe and beyond;
- encouraging exchange of ideas as much as possible;
- organising international sports history congresses and conferences to reinforce awareness of a common heritage;
- promoting the emergence and formation of young researchers;
- calling upon European-level specialists to serve as support for young people;
- harmonising European sport teaching standards in Europe at the highest university level;
- facilitating international research projects;
- accelerating comparative research into European sports history;
- facilitating exchange of bibliographical material;
- building a wide network of researchers;
- creating a European dimension in sports history studies;
- creating a European Doctorate and Masters in sports history;

- encouraging knowledge of European languages among sports history researchers given due respect to local, regional and national traditions;
- publishing and spreading research results in as wide a manner as possible;
- encouraging audio-visual production in order to develop a European-dimension education;
- promoting actions safeguarding sports history archives and disseminating material and archive protection.

In order to achieve these goals, a European Committee for Sports History (CESH) was established within the European Network of Sports Sciences Institutes. CESH is without profit-making purposes and is made up of individual and institutional members.

1. NAME

The organisation shall be called the European Committee for Sports History (CESH). It shall have its logo and motto as *cognita historia futurum figurare*.

2. STATUTES AND SOCIAL SEAT

- 2.1. CESH is an organisation without profit-making objectives, in conformity with European law. It pursues scientific objectives and international accord. Everything shall be done to assure its statutes exonerate it from taxation.
- 2.2. No member shall make a profit from CESH, with the exception of reimbursement of expenses on the basis provided for by European institutions or fixed conditions for using received emoluments. CESH co-operates with the European network of sports sciences in higher education. The seat or location shall be the postal address of the President.

3. Internal Regulations

The Directing council presents Interior Regulations which have to be approved by the General Assembly. These aim at a correct running of the daily business of the directing Council.

4. CATEGORY OF MEMBERS

- 4.1. There are five categories of members: members, Fellows, honorary members, honorary Fellows, and institutional members.
- 4.2. Any *bona fide* researcher (in all good faith) in sports history who works in a European Union nation or in a country which has an equivalent statute in regard to cultural and educational exchange may be *Member*. The Directing Council may refuse membership for justified reasons.
- 4.5. Any Member who, having published at least one monograph on sports history, adheres to the CESH objectives, is a paid-up CESH member, commands two languages, has presented a scientific paper in at least two CESH congresses, and will be present at the next CESH congress, may be elected to the College of Fellows as a *Fellow*, with less than 10% of negative votes. Annual membership of the College of Fellows is dependent on the payment of the annual CESH membership fee for that year.

- 4.7. Joining as *Honorary Fellow* may be conferred on any researcher in line with attaining the status of Fellow and who has produced significant contributions to sports history. Honorary Fellows are elected with less than 10% of negative votes of the College of Fellows and enjoy the same rights as the latter. They are excused payment of the annual membership fees.
- 4.8. Any *bona fide* institution (in all good faith) in sports history may be *Institutional Member* and receive a copy of the journal. In order to become such, a representative of this institution must ask to join.

5. GENERAL ASSEMBLY

- 5.1. The General Assembly is the primary organ of CESH and is constituted by all paid-up members with the right to vote.
- 5.2. CESH holds a General Assembly of Members where possible annually at its International Congresses or Conferences. The President proposes the agenda. Members may propose agenda items with supportive papers. The General Secretary announces one month in advance by any proper means the CESH annual reunion to each paid-up member with the right to vote. This information is also published on the CESH website. This information indicates the time, place and anything concerning the general conditions of the reunion.
- 5.3. The General Assembly lays down the lines of development of the association, makes fundamental decisions, deliberates on the function of executive and representative organs, and constantly exercises appropriate action so that all activities are in line with the conditions of the present statutes. Its deliberations are sovereign.
- 5.4. The status of CESH member is in line with the version of the annual associative fee established by the General Assembly on the proposition of the Directing Council and within the conditions determined by the Interior Regulations.
- 5.5. Within the Assembly each member cannot represent any other member as a means of voting or nomination.
- 5.6. The General Assembly possesses the following obligations:
- approves the financial account of the past year and its appropriate report;
 - elects for four years by secret ballot the CESH President, the General Secretary, and the Treasurer
 - co-opts the Vice-President,
 - nominates two auditors;
 - determines the directions that the Association's activity should take;
 - assesses and ultimately approves the activity programmes decided on by the Directing Council or whoever might be interested in the final decisions of the Association;
 - approves ultimately the Interior Regulations proposed by the Directing Council necessary for good associative functioning before they become valid;
 - deliberates on other subjects inscribed in the agenda;
 - elects a recorder and ensures that minutes are being kept.

6. DIRECTING COUNCIL

- 6.1. In the event of differing interpretations of the statutes, the conduct of CESH is decided upon by the Directing Council. The President presides over the Directing Council.
- 6.2. The Directing Council is made up of the President, the General Secretary, the Treasurer, for four years each, and of the President Elect or the Past President, for two years each.

- 6.3. One Vice President may be co-opted by the General-Assembly with certain tasks concerning the organisation of the congresses and conferences. The position of Vice President may not last for longer than 30 months.
- 6.4. The elected officers have the usual duties that accord with such charges and which are further described in the Interior Regulations. The Vice President endorse also the duty of Organising and Scientific Committee for the next international CESH congress under preparation. The Vice Presidents charged with other specific duties may also be elected at the General Assembly. After having informed the President and obtained his consent, any Member of the Directing Council has the right to represent CESH by himself or herself, unless other dispositions have been taken.
- 6.5. In case of the stepping down of the President or his declared indisposition, the conduct of the Directing Council is conferred on the President Elect. In the absence of the latter, the General Secretary is named interim President until the next General Assembly.
- 6.6. The Directing Council is quorate when half plus one of voting members is present. It is presided over by the President or, on his/her absence, by the President Elect. The General Secretary fulfils the functions of the Council Secretary. The Directing Council deliberates always with a simple majority of those present. In the event of an equal number of votes, the vote of whoever presides over the meeting prevails. If financial matters are at stake no decisions can be taken against the explicit vote of the Treasurer.
- 6.7. The Directing Council may accept votes by correspondence or by e-mail. Apart from differing interpretations of the laws or the present statute, the decisions of the Committee are taken on the basis of a simple majority.
- 6.8. The Directing Council shall present to the General Assembly final reports for the term since the previous General Assembly of the President, the General Secretary, and of the Treasurer. The reports must contain all the operations undertaken by CESH and which concern the acceptance of members in terms of paragraph 4.

7. COLLEGE OF FELLOWS

- 7.1. In line with Article 3, all Fellows and Honorary Fellows shall form the College of Fellows. This latter shall elect a President who deals with the nominations of President Elect, General Secretary, and Treasurer to be proposed to the General Assembly. The College shall also be concerned with running the College of Fellows. The period of duties is two years. Election is held one year before the end of term with the possibility of being re-elected once. The President of the College of Fellows may nominate a Secretary of his/her choice.
- 7.2. The College of Fellows proposes the new officers to the General Assembly vote. If the General Assembly does not accept the candidatures of the College, the Fellows of the College who are present take a time out and propose other officers to the same General Assembly. The College shall elect new Fellows and Honorary Fellows with less than 10% of negative votes.

8. DUES AND FINANCES

- 8.1. The amount of the annual dues for all classes of CESH membership shall be determined by vote of the General Assembly upon proposal of the Treasurer.
- 8.2. CESH members who are full-time students or unemployed shall be assessed reduced annual dues.
- 8.4. Members, who are members of CESH and a national section which is accredited by CESH shall be assessed a reduced percentage of the annual dues.

8.5. CESH membership terminates on 31 December if fees are not paid for the following year.

8.6. Participants presenting a research at CESH congresses must be CESH-members for the civil year in which the congress is held.

9. CANDIDATURE to elections in the Directing Council

Candidatures to elective functions in the Directing Council (President, General Secretary and Treasurer) are presented to the President of the College of Fellows not later than 60 days before the date of the elective General Assembly. The President of the College shall be responsible for communicating to all voting members and for publishing on the CESH website the list of candidates as well as the election date of the President of the College of Fellows. The candidates for President of the College of Fellows shall be proposed not later than 60 days before the date of the reunion of Fellows. In order to incorporate more CESH members in leading elective functions, all holders of such functions cannot be re-elected, unless stated otherwise.

10. NATIONAL SECTIONS AND WORKING GROUPS

By a request to the Directing Council of at least three CESH members, it is possible to organise National Sections and Working Groups. They shall present each year to the Directing Council an account of their work. These national sections shall be accredited by the General Assembly.

11. OFFICIAL WEB SITE

CESH has its own website (www.cesh-site.eu) operated on a regular basis by the President and by the General Secretary, to whom everyone may signal news or information of interest to sport historians.

12. DISSOLUTION OF CESH

CESH may be dissolved by a vote of three-quarters of all CESH members, who answered by postal ballot. Sums of money remaining in the account may be given to a Foundation chosen by the General Assembly.

INTERIOR REGULATIONS

Page | 1

The object of the Interior Regulations is to specify the Statutes of the European Committee for Sports History (CESH).

1. Members and Fellows

1.1 Fellows

In accordance with article 4 of the Statutes, all Fellows and Honorary Fellows constitute the College of Fellows. The latter is autonomous and decides matters at its own discretion. It elects a President who may or may not participate in the Directing Council and who is in charge of bringing together the candidates for the positions of President Elect, General Secretary and Treasurer in order to put them forward at the General Assembly. In order to do so, he consults the College of Fellows on the internet and, 60 days before the General Assembly, proposes candidates to the College of Fellows.

The term of office of the President of Fellows is two years. The President of Fellows may only be re-elected once. The President of the College of Fellows appoints a Secretary of her/his choice. The College of Fellows puts forward new candidates for the Directing Council to the vote of the General Assembly. If the General Assembly does not accept the College of Fellows' candidates, the Fellows then – after a time-out – put forward new candidates at the same General Assembly. The College of Fellows elects its new Fellows and Honorary Fellows with less than 10 % of negative votes.

The President of the College of Fellows organises, in co-operation with the President of CESH, a meeting of Fellows before every General Assembly.

1.2 Members

Exclusion

A member may be excluded on the extraordinary decision of the Directing Council and with the consent of the majority of its members present. Before such an action the member concerned must be given a chance of a written vindication.

Resignation – Death – Disappearance

The member resigning must notify the President and the other members of the Directing Council of his/her decision by a simple letter. If a Fellow does not pay the membership fees, he/she loses his/her CESH membership and his/her status as a Fellow for the time fees are not paid.

2. Directing Council

According to Article 6 of the Statutes, members of the Directing Council have the following rights and duties.

2.1. The President in Office of CESH

The Presidency in Office of CESH:

- is responsible for relationships with the outside world,

- organises life in CESH, and ensures its smooth functioning,
- signs important acts,
- convenes the General Assembly and decides on the agenda with the other members of the Directing Council,
- in case of necessity he/she may give his/her proxy to the to the President Elect,
- together with the President of the College of Fellows and the President of the Scientific Committee of the annual CESH congress, he/she co-ordinates the meeting which decides on the Award winners.

2.2. The Past President and the President Elect

Participate in the smooth functioning and in the decision-making of the Directing Council.

2.3 The President of the College of Fellows

Fulfils the function described in Article 7 of the Statutes.

Co-ordinates, in agreement with the CESH President and the President of the Scientific Committee of the annual CESH congress, the meeting which decides the Award winners.

2.4 The Vice President

Are responsible for organising the next International CESH congress and subsequently work as editor to publish the congress proceedings.

2.5. The General Secretary and Treasurer

Fulfil the usual duties as shown in Article 6 of the Statutes.

3. Functioning of CESH

3.1. General Assembly

The members are invited to the General Assembly by email at least 30 days before the scheduled date; this notice will also be posted on the website of CESH.

The voting modalities are proclaimed before each ballot.

At the request of one of the members, voting may be carried out by secret ballot.

A Recorder for the session is designated at the beginning of the General Assembly. He/she records the minutes of the General Assembly.

No votes by proxy are permitted. Decisions are made according to the majority of the members present.

3.2. Extraordinary General Assembly

An Extraordinary General Assembly may meet in the event of an essential modification of the Statutes or as the occasion may require.

All members are invited by email at least 30 days before the scheduled date.

The vote is held by secret ballot.

No votes by proxy are permitted.

Decisions are made according to the majority of the members present.

3.3 Annual Subscriptions

Members (including Fellows) must pay an annual fee to be a CESH member.

Its amount is to be determined annually by the General Assembly on a proposition of the Directing Council and of the Treasurer whose vote cannot be overruled.

Students and Unemployed are entitled to a discount.

The annual fee must be paid before the General Assembly in order to be able to vote.

All fees paid to CESH are non-refundable. No fee shall be refunded during the year in the event of resignation, exclusion or death of a member.

Speakers at CESH congresses must be CESH members.

Those who pay their fees during the year and according to the Statute conditions shall be deemed to be members and/or Fellows. Page | 3

3.4. Expenses

Members of the Directing Council may have parts of their travel expenses for attending an International CESH Congress refunded according to the current official rates on the proposition of the Directing Council and of the Treasurer, whose vote cannot be overruled. A refund can only be granted if the applicant does not receive any financial aid from a secondary source.

4. International Annual CESH Congresses

4.1 The Scientific Committee of CESH Congresses

The CESH President in Office is a member of the Scientific Committee of every International CESH Congress. In collaboration with her/him, the local organisers decide on the composition of the Scientific Committee. The head of the Organising Committee must pay his/her membership at least during the years until the congress is held.

4.2 The Choice of the CESH Congress Venue

The choice of a Congress Venue is decided during the General Assembly.

In the event of a change, after the General Assembly's decision (cancellation of the intended International Congress), the Directing Council shall have full discretion to decide on a new venue for the CESH Congress.

4.3 Conditions of Candidature for CESH Congress Organizers

The candidature for International CESH Congresses is presented to the vote of the General Assembly, if possible already two years before its intended date.

It shall be presented by a member of CESH with the endorsement of a university.

One year before, the local organisers shall present the programme outline abiding by the schedule of International CESH Congresses.

The local organisers must provide:

- travel and accommodation costs for two guest lecturers,
- a hall for the assembly and rooms for simultaneous sessions,
- a reasonable registration fee (about 100 to 120 €) and relatively cheap accommodation in order to encourage the presence of young researchers,
- the Congress advertisements and invitations,
- the publication of Summaries and Proceedings, and
- an Official Opening and Closing Ceremony.

4.4 Standards of Publication

CESH has its own standards and Authors' Guidelines in various different European languages. The local organisers can only deviate from and change them if absolutely

necessary, provided that they present slight alterations to the General Assembly along with their candidature.

4.5 Official Languages of the International CESH Congresses and Publications

All European languages are allowed for communication; but participants are asked to answer questions either in French, in English, or in the language of the host after having read their papers. Page | 4

All European languages are accepted for publication of the Proceedings.

5. Scientific Activities and Grants

5.1. Awards

Candidates for Awards must forward their papers to the local organiser according to the modalities previously specified by CESH and the Scientific Committee.

Papers are sent to the local Scientific Committee by email thirty days before the International CESH Congress.

Two reviewers, as proposed by the Presidents of the College of Fellows and of the Scientific Committee, are designated for each article.

After having heard the reviewers, the members of the Scientific Committee shall vote on the best contribution for each Award.

5.2 CESH journal / ESSH

A journal entitled *European Studies for Sports History (ESSH)* is published on a regular basis and is the official organ of CESH.

The General Assembly appoints an Editorial Board and a Scientific Committee the members of which are chosen from among the Fellows of CESH who are prepared to join in and further (sports) historians of an undisputed scholarly reputation.

The Directing Council shall appoint an editor according to his/her proficiency and availability in the field of historical sports science.

CESH must ensure the promotion of this journal through all possible means.

All European languages are accepted. Authors' Guidelines in different European languages are listed on the CESH website.

6. Miscellaneous Provisions

6.1 Modification of the Interior Regulations

The Interior Regulations are drafted by the Directing Council and then ratified by the General Assembly.

The new Interior Regulations are sent to all members of CESH by email one month after their ratification and publication in the draft minutes of the relevant General Assembly.

6.2 Eligibility

A President of CESH cannot be elected twice.
